Dear Business Owner,

I'm Scott McDaniel, President and co-founder of the Susquehannock Wildlife Society. We are hosting a large fundraising event in June. Our "Night with the Wild" gala will be held at Deer Creek Overlook on June 17, 2016 starting at 7:00 p.m.

We are raising funds for our region's first dedicated wildlife center. The Susquehannock Wildlife Society is now managing a beautiful 20 acre site in Harford County that has been set aside to protect wildlife and its habitat. The existing house and barn on the property will be renovated and converted into a first-of-its-kind local wildlife center devoted to education, research, and rehabilitation of our native species. Within the wildlife center, visitors will be educated and entertained by museum-quality displays, hands-on activities and live-animal education ambassadors. Having a permanent facility will also allow Susquehannock Wildlife Society to expand its already active and successful wildlife rescue and rehabilitation efforts – helping licensed wildlife rehabbers to care for and house local injured and orphaned animals until they can be released back into the wild.

Once completed, visitors will be given the opportunity to hike more than a mile of trails along a creek, past a pond, and through meadow and woodland; offering excellent bird and wildlife watching opportunities with scenic views of the countryside.

Our gala will bring over 300 supporters and all participating businesses will be prominently featured during the event. Plus, all participating businesses will be displayed on our web site for the entire year. Can you help?
